#### GMPIPE DATA CONTROLLER APPLICATION FORM

#### 1. General Information

In accordance with the Law on Protection of Personal Data No. 6698 ("KVKK"), personal data owners ("Applicant") have the right to make certain requests regarding the processing of their personal data. This application form has been prepared to determine your relationship with GMpipe and to ensure your requests are answered correctly and promptly.

To ensure the security of your personal data and prevent unlawful data transfers, GMpipe may request additional information for identity and authorization verification. The Applicant is responsible for ensuring that the information provided is accurate and/or upto-date and that the requests are authorized.

According to the Communiqué on the Procedures and Principles of Application to the Data Controller, no fee is charged for written responses to applications up to ten pages. For responses over ten pages, a fee of 1 Turkish Lira per page may be charged. If the response is provided on a recording medium such as a CD or flash drive, the cost of the recording medium may be charged.

## 2. Scope of the Right to Application Under Article 11 of KVKK

The Applicant can make the following requests to GMpipe:

- 1. Learn whether their personal data is processed,
- 2. Request information if their personal data has been processed,
- 3. Learn the purpose of processing personal data and whether it is used in accordance with the purpose,
- 4. Know the third parties to whom personal data is transferred domestically or abroad.
- 5. Request correction of personal data if it is incomplete or incorrectly processed and request notification of the correction to third parties to whom the personal data has been transferred.
- 6. Request the deletion or destruction of personal data if the reasons for processing no longer exist, despite being processed in accordance with KVKK and other relevant laws, and request notification of the deletion or destruction to third parties to whom the personal data has been transferred,
- 7. Object to the occurrence of a result against the person himself/herself by analyzing the processed data exclusively through automated systems,
- 8. Demand compensation if they suffer damage due to unlawful processing of personal data.

#### 3. Application Method

Pursuant to Article 13 of KVKK, applications related to these rights must be submitted to us in writing and signed, or by other methods determined by the Personal Data Protection Board ("Board").

In this context, applications to be made in writing can be sent by:

- The Applicant personally delivering the application with a document verifying their identity,
- Notary,
- Registered electronic mail (KEP) address, secure electronic signature, mobile signature, or
- Email sent from the Applicant's email address previously notified to us and registered in our system.
